## **RECOMMENDATION**

It is recommended that the Board approve, and direct the Chair to sign, an amended resolution previously approved by the Board on May 15, 2012, of an agreement between the County and the State Victim Compensation and Government Claims Board (VCGCB) for the period of July 1, 2012 through June 30, 2015, adding the maximum amount of \$545,588 available from the State for that period, with all other provisions remaining the same.

As previously reported to the Board, this action will enable the District Attorney's Victim/Witness Assistance Center to receive \$215,196 in FY 2012-13 to offset the cost of assisting victims of crime in the verification of State reimbursement compensation for crime-related financial losses pursuant to Government Code Section §13954(c).

## **DISCUSSION**

An amended resolution is required by the State VCGCB as the resolution language must include the maximum amount of the agreement (\$645,588) between the State and the County for the period of July 1, 2012 through June 30, 2015. All other resolution provisions remain the same as previously approved by the Board on May 15, 2012. No changes were required or made to the agreement.

## **OTHER AGENCY INVOLVEMENT/IMPACT**

The Administrative Office and County Counsel have reviewed the amended resolution. County Counsel has approved the amended resolution.

## **FINANCIAL CONSIDERATIONS**

As previously reported on May 15, 2012, a maximum of \$645,588 is available from the State Victim Compensation and Government Claims Board (VCGCB) for the period of July 1, 2012 through June 30, 2015, with \$215,196 available to the District Attorney's Victim/Witness Assistance Center for FY 2012-13. This amount is the same as last year's allocation with no matching funds required, and will continue to reimburse salaries and benefits for claim verification staff, and a portion of the Director's salary.

## **RESULTS**

As previously reported on May 15, 2012, approval of this resolution with the State VCGCB will allow the District Attorney's Victim/Witness Assistance Division to work with the State to process 100% of victim compensation claims for state reimbursements of crime-related financial losses within 90 days of receiving an application and achieve other related Departmental Performance Measures.
