**RESOLUTION AUTHORIZING THE DISTRICT ATTORNEY TO SIGN, ON BEHALF OF
THE BOARD OF SUPERVISORS, AN AGREEMENT BETWEEN THE VICTIM
COMPENSATION AND GOVERNMENT CLAIMS BOARD AND THE COUNTY OF
SAN LUIS OBISPO (AGREEMENT #VCGC2058) FOR THE VERIFICATION OF
CRIME VICTIM COMPENSATION CLAIMS**

The following resolution is hereby offered and read:

WHEREAS, the County of San Luis Obispo has previously entered into an agreement with the Victim Compensation and Government Claims Board (VCGCB), to provide compensation to victims of crime, as empowered by Government Code §13950 et seq., and desires to continue the program to expeditiously process claims for the unreimbursed losses of victims of crime; and

WHEREAS, the VCGCB has selected the San Luis Obispo County District Attorney's Victim/Witness Assistance Center (hereafter referred to as Center) to receive "Joint Powers" monies for the purpose of verification of victim claims annually since 1989 and for fiscal year beginning July 1, 2012 through June 30, 2015, and;

WHEREAS, the VCGCB has allocated a maximum of \$645,588 for fiscal years 2012-2015 for this specific task, and;

WHEREAS, the VCGCB has authorized and allocated \$215,196 for the period of July 1, 2012 through June 30, 2013, to implement this project subject to the execution of a Standard Agreement and acknowledgement of the terms and conditions contained therein; and

WHEREAS, the County desires to participate in such a program for the verification of victim claims within its program area, and has the capability of providing

such services through its Center, and;

WHEREAS, the Center is the major provider of comprehensive services to victims and witnesses in San Luis Obispo County;

NOW, THEREFORE BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, as follows:

That the District Attorney of the County of San Luis Obispo is authorized to submit the VCGCB Standard Agreement (Agreement) and is authorized to execute on behalf of the Board of Supervisors the Agreement including any extensions or amendments thereof.


