**RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC WORKS
TO APPLY FOR LOANS AND GRANTS FROM THE
UNITED STATES DEPARTMENT OF AGRICULTURE
FOR ELIGIBLE PROJECTS**

The following Resolution is now offered and read:

WHEREAS, the County wishes to improve community facilities in all communities throughout the county; and

WHEREAS, The Department of Public Works proposes to apply for Federal funding administered by the United State Department of Agriculture (USDA) Rural Development; and

WHEREAS, the USDA Rural Development financial programs support essential public facilities and services such as water and wastewater systems and other community facilities including storm drain systems in rural areas; and

WHEREAS, the USDA Rural Development Community Facilities Programs provide loans, grants and loan guarantees for projects to develop essential community facilities for public use in rural areas; and

WHEREAS, the USDA Rural Development Water Programs provide financial and technical assistance for development and operation of safe and affordable water supply systems and sewage and other forms of waste disposal facilities; and

WHEREAS, there are numerous projects within the County that may be eligible for USDA Rural Development program funding; and

WHEREAS, the Director of Public Works is especially suited to ensure that loan and grant application materials related to water projects are prepared in a complete, efficient, and adequate manner.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, that:

1. Applications are made to the United States Department of Agriculture Rural Development Community Facilities and Water Programs for loans and/or grants for eligible projects throughout the County.
2. The Director of Public Works of the County of San Luis Obispo is hereby authorized and directed to prepare the necessary documentation required for USDA Rural Development Community Facilities and Water Programs funding and file such applications.
3. If applications are successful and funding through loans or grants are awarded for specific project(s), the Director of Public Works of the County of San Luis Obispo is directed to return to this Board for approval to execute such loan or grant agreements (approved as to form by County Counsel).
