**RESOLUTION OF THE BOARD OF SUPERVISORS  
ACTING AS THE GOVERNING BOARD OF SAN LUIS OBISPO  
COUNTY SERVICE AREA 10A (CAYUCOS – WATER SERVICE)  
COUNTY SERVICE AREA 16 (SHANDON - WATER SERVICE),  
AND 23 (SANTA MARGARITA - WATER SERVICE),  
RESOLUTION VERIFYING DELINQUENT SERVICE  
CHARGES AND CONFIRMING REPORT**

The following Resolution is now offered and read:

**WHEREAS**, Government code Section 25215.5 provides authorization for collection of delinquent service charges on the property tax bill; and

**WHEREAS**, this Board, after due notice was given, have duly held a public hearing concerning the addition of delinquent service charges to the 2012-13 property tax bills; and

**WHEREAS**, at said hearing, a report (Exhibit A) containing such delinquent charges was duly received by said Board; and

**WHEREAS**, at said public hearing opportunity was given for filing objections and protests and for presentation of testimony or other evidence concerning the same; and

**WHEREAS**, it is in the public interest that this Board adopt the delinquent charges and confirm the report (Exhibit A) presented at the hearing.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** by the Board of Supervisors of the County of San Luis Obispo, State of California, Acting as the Governing Board of San Luis Obispo County Service Area Nos. 10a, 16 and 23 as follows:

1. That the recitals set forth herein and above are true, correct, and valid.
2. That this Board hereby adopts the delinquent charges set forth on the attached report marked Exhibit "A," which is hereby expressly incorporated herein by reference as though here fully set forth; and this Board hereby confirms the report containing such charges as set forth in said Exhibit "A."
3. That the delinquent charges are so confirmed and adopted shall appear as separate items on the tax bill of each parcel listed in said report (Exhibit A), and such delinquent charges shall be collected at the same time and in the same manner as ordinary County ad valorem taxes are collected, and are subject to the same penalties and the same procedure and sale in case of delinquency as provided for such taxes.
4. Direct the Clerk to file the certified copy of this resolution and said approved and confirmed report (Exhibit A) of delinquent charges with the County Auditor no later than August 10, 2012.
