## **RECOMMENDATION**

It is our recommendation that your Honorable Board, acting as the San Luis Obispo County Flood Control and Water Conservation District:

1. Approve subject resolutions (2) and collect assessments as stipulated therein; and
2. Direct the Clerk to file the approved Resolutions with the County Auditor no later than August 10, 2012.

## **DISCUSSION**

The benefit assessment funds activities associated with the Arroyo Grande Creek improvements (Zone 1), and the Los Berros diversion channel to Arroyo Grande Creek (Zone 1A). This rate has been in effect more than twenty-three years. The current rate was in effect when Proposition 218 was passed. No vote on these current assessments is required unless the rate is to be increased. On June 6, 2006, voters approved an additional annual assessment to fund increased maintenance activities. This additional assessment will be brought to your Board in a separate item.

## **OTHER AGENCY INVOLVEMENT/IMPACT**

Tax Collector collects the charges on the tax roll, Auditor/Controller places the charges on the tax roll and County Counsel has approved the Resolution as to form and effect. The County Clerk will file the Resolution with the Auditor/Controller.

## **FINANCIAL CONSIDERATIONS**

Section 13 of the San Luis Obispo County Flood Control Act 7205 allows for the recovery of costs associated with the maintenance and improvement of the subject drainage projects. The amount of the assessment, per parcel, is \$10.00 per acre rounded to the nearest 1/2 acre. The revenues are

included in the proposed Flood Control Zone 1 and 1A budgets for 2012-13. The total of this assessment levied in Flood Control Zone 1 will be approximately \$17,000, which represents 3% of the district funding. The total of this assessment levied in Flood Control Zone 1A will be approximately \$2,100, which represents 8% of the district funding.

## **RESULTS**

Approximately \$17,000 in Flood Control Zone 1 and \$2,100 in Flood Control Zone 1A will be added to the property tax bills in the respective districts for 2012-13. This revenue will be used to finance flood control services within the respective districts. See resolution exhibit for amount charged each parcel.
