**RESOLUTION ACCEPTING CERTAIN ROADS
INTO THE COUNTY ROAD SYSTEM
COUNTY ROAD NUMBERS 4394 AND 4395
AND ACCEPT A VARIABLE WIDTH ROAD WIDENING
INTO THE COUNTY ROAD SYSTEM COUNTY ROAD NO. 5330**

The following Resolution is hereby offered and read:

WHEREAS, the County of San Luis Obispo, State of California, has been duly requested to accept the offer to dedicate certain roads into the maintained system; and

WHEREAS, the County of San Luis Obispo, State of California, has been duly requested to accept a certain offer to dedicate for a variable width road widening of a road presently in the maintained system in said County; and

WHEREAS, the County Surveyor, by letter, has duly recommended that the Board of Supervisors:

Accept the offer of dedication for public use of Tessa Court, Jacob Way, and Rossi Road as shown on Tract 2492.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, by the Board of Supervisors of the County of San Luis Obispo, State of California:

1. That the offer to dedicate of 0.049 mile of Tessa Court, County Road No. 4394, 0.050 mile of Jacob Way, County Road No. 4395, and the variable width road widening of Rossi Road, County Road No. 5330, as shown on Tract 2492 as filed in Book 27, of Maps, at Page 19 through 24 inclusive of Maps in the Office of the County Recorder is hereby accepted into and made a part of the County Road System, to be maintained in kind, and shall and do constitute County highways in the County of San Luis Obispo.
2. That the County Clerk be and hereby is authorized and directed to record a copy of the Resolution in the Office of the County Recorder of the County of San Luis Obispo.
3. Said offer of dedication is offered by Shane Creek, LLC.


