## **RECOMMENDATION**

It is recommended that the Board of Supervisors adopt the resolution recognizing July 15-21, 2012 as Probation Services Week in the San Luis Obispo County.

## **DISCUSSION**

The American Probation and Parole Association designates one week each year as Probation Services Week. During Probation Services Week, people across America will join together to honor and celebrate the work done by Probation employees.

The role of the Probation Department is to keep the community safe, reduce recidivism among those placed under Probation's supervision and to return restitution due to victims. In order to accomplish this, the Department has adopted the evidence-informed *Risk, Needs and Responsivity* model.

In October 2011, the Probation Department assumed the responsibility of supervising certain parolees that were realigned from State Parole under AB 109.

The Probation Department continues to have dedicated and hard working staff that are committed to the public safety of San Luis Obispo County.

The recidivism rates for Fiscal Year 2011-12 were 3.15% for Adult Probationers and 4.7% for Juveniles.

In Fiscal Year 2011-12, the Probation Department returned an average of \$60,000 a month of restitution to victims.

Probation Services Week has been celebrated annually by the San Luis Obispo County Probation Department since 2006.
