**RESOLUTION OF THE BOARD OF SUPERVISORS
ACTING AS THE GOVERNING BOARD OF SAN LUIS OBISPO
COUNTY SERVICE AREAS NOS. 7-A (OAK SHORES),
16-1 (SHANDON), 18 (COUNTRY CLUB ESTATES) AND
23 (SANTA MARGARITA) RESOLUTION VERIFYING
DELINQUENT AVAILABILITY CHARGES AND CONFIRMING REPORT**

The following resolution is hereby offered and read:

WHEREAS, Government Code Section 25215.6 provides authorization for collection of delinquent sewer and water availability charges on the property tax bill; and

WHEREAS, Section 54354-54358 of the Government Code authorizes the Board of Supervisors to declare that delinquent charges and penalties shall constitute a lien upon the real property served: and

WHEREAS, it is in the public interest that this Board confirm the delinquent availability charges and direct their collection on the 2012-13 tax roll.

NOW, **THEREFORE, BE IT RESOLVED AND ORDERED** by the Board of Supervisors of the County of San Luis Obispo, State of California, acting as the Governing Board of San Luis Obispo County Service Areas Nos. 7-A, 16-1, 18 and 23 as follows:

1. That the recitals set forth herein and above are true, correct, and valid.
2. That this Board hereby adopts the delinquent availability charges set forth on the attached document marked Exhibit "A," which is hereby expressly incorporated herein by reference as though here fully set forth; and this Board hereby confirms the report containing such charges as set forth in said Exhibit "A."

3. That the delinquent availability charges as so confirmed and adopted shall appear as separate items on the tax bill of each parcel listed in said report, and such charges shall be collected at the same time and in the same manner as ordinary County ad valorem taxes are collected, and are subject to the same penalties and the same procedure and sale in case of delinquency as provided for such taxes.
4. The Clerk shall file a certified copy of this resolution and said approved and confirmed report of delinquent charges with the County Auditor no later than August 10, 2012.
