RECOGNIZING CENTRAL COAST FUNDS FOR CHILDREN FOR THEIR
EXEMPLARY SERVICE TO THE CHILDREN AND FAMILIES
OF SAN LUIS OBISPO COUNTY**

The following resolution is hereby offered and read:

WHEREAS, Family Care Network, Inc. has selected Central Coast Funds for Children as the 2012 recipient of their "Circle of Serving" Award, for their extraordinary efforts towards enhancing the wellbeing of children and families in San Luis Obispo County through years of exceptional community service and support; and

WHEREAS, Central Coast Funds for Children is a volunteer-driven organization whose members demonstrate an exceptional dedication to children, youth and families with special needs living in San Luis Obispo County. Members raise all of the group's funds through private and business donations, dues, and fundraising efforts, and allot less than 6% of their annual budget to cover expenses; and

WHEREAS, Since its inception in 1994, the Central Coast Funds for Children has awarded over \$1 million in grants to over 85 local organizations, including but not limited to: Big Brothers, Big Sisters of SLO County; CASA; the Child Development Center; Food Bank Coalition; Sexual Assault Recovery & Prevention; the Special Olympics of SLO; and the Women's Shelter Program of SLO, demonstrating their high commitment to supporting vital community services and programs; and

WHEREAS, Central Coast Funds for Children volunteers dedicate over 3,400 hours a year to meet the needs of San Luis Obispo County's community, including hosting two main fundraising events - the Annual Soup Supper and Christmas in November - in addition to working at other community-hosted events such as the Morro Bay Kite Festival and Camp Reach for the Stars for children fighting cancer; and

WHEREAS, Central Coast Funds for Children exemplifies the mission of the Family Care Network "to enhance the wellbeing of children and families on the Central Coast in Partnership with the Community." Central Coast Funds for Children continually promotes and encourages a high level of community involvement in efforts that directly benefit our community, and as a result, stand as an inspiration to us all. It is our honor to celebrate this incredible organization for being an outstanding model of community service at its most effective.
