DISCUSSION

The Atascadero Colony Days Committee is a non-profit organization. Colony Days attracts tourists and vendors from as far away as Santa Maria, Brea, Santa Rosa, Lompoc, San Jose as well as locals from every part of the County. There will be an Arts & Crafts fair, car show, horse events, games, entertainment and great food. The event attracts more and more people each year, thereby, stimulating the economy of the County. The event will be held on October 20th, 2012. Locally, the event will be advertised with street banners and television, radio and newspaper advertising. The event is free to the public. The \$1,800 in County grant funds will be used towards expenses associated with holding the annual Atascadero Colony Days, including, but not limited to, advertising, road closure fees and entertainment costs.
