SUBJECT: Request for the Board of Supervisors to make appointments in-lieu of election.

RECOMMENDATION

It is recommended that your Board appoint the persons named on the list below to the appropriate district board offices in lieu of election.

DISCUSSION

August 10, 2012 was the close of nomination period for the November 6, 2012 Consolidated General Election and August 15, 2012 was the end of the extension period for anyone other than the incumbents to file for office. After the close of the filing period, it was determined that the number of candidates filing for the respective district offices did not exceed the number to be elected. Per Elections Code Section 10515, districts are not required to hold an election unless a petition requesting that the general election be held is presented to the elections official. No such petition was filed for any district. Your Board has the authority to make appointments for those candidates who filed nomination papers and for those persons whose names were submitted as nominees by their district boards, lists included with this letter. Persons appointed by your Board in this manner will serve as though elected at a general district election.

OTHER AGENCY INVOLVEMENT/IMPACT

All districts requesting appointments to offices in lieu of election.

FINANCIAL CONSIDERATIONS

The districts which are not required to hold elections will reimburse the county only for the nominal costs of conducting the nomination process and will save the costs associated with conducting an election. This will increase the cost per registered voter for all other districts on the General Election ballot and may result in an insignificant reduction in election related revenue for the County Clerk-Recorder.

RESULTS

To complete the process of appointment of those persons who filed the necessary nomination documents for election to various district offices in the November 6, 2012 Consolidated General Election and of those persons who were submitted as nominees by various districts (listed below).
