**RESOLUTION ACCEPTING CERTAIN ROADS
INTO THE COUNTY MAINTAINED ROAD SYSTEM
ROAD NOS. 5550 and 5551**

The following resolution is hereby offered and read:

WHEREAS, on May 17, 2011, the San Luis Obispo County Board of Supervisors by Resolution No. 2011-149 authorized the execution of agreements between the County and the State of California to complete and implement the following route transfers in the community of Shandon:

1. West Centre Street from State Route 41 easterly to Truesdale Road; and East Centre Street from Truesdale Road easterly to State Route 46 be transferred from the State to the County; and
2. West Centre Street from State Route 41 westerly to State Route 46 be transferred from the County to the State.

WHEREAS, on September 15, 2011, the State of California, California Transportation Commission by Resolution R-3810 adopted the relinquishment of West Centre Street from State Route 41 easterly to Truesdale Road; and East Centre Street from Truesdale Road easterly to State Route 46 to the County of San Luis Obispo; and

WHEREAS, on September 15, 2011, the State of California, California Transportation Commission by Resolution HRA 11-01 accepted West Centre Street from State Route 41 westerly to State Route 46 and officially designated it as State Highway 05-SLO-41; and terminated any obligation by the County to further maintain West Centre Street; and

WHEREAS, on December 16, 2011, the County of San Luis Obispo received official notice of route transfer completion from the State Department of Transportation in accordance with the Streets and Highway Code, Section 82.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, by the Board of Supervisors of the County of San Luis Obispo, State of California:

1. Accept 1.246 miles of West Centre Street, County Road No. 5550, and accept 1.354 miles of East Centre Street, County Road No. 5551, into the County Road System.
2. That the County Clerk be and hereby is authorized and directed to record a copy of the resolution in the Office of the County Recorder of the County of San Luis Obispo.
