**RESOLUTION RECOGNIZING ERIC GREENING FOR HIS YEARS OF PUBLIC

The following resolution is hereby offered and read:

**WHEREAS**, Eric Greening has served the County of San Luis Obispo as a citizen representative on the Water Resources Advisory Committee and the Citizen's Transportation Advisory Committee since 1994, the Regional Transit Advisory Committee since 2006 and several other committees convened for special purposes; and

**WHEREAS**, Eric regularly appears before the Board of Supervisors, San Luis Obispo County Planning Commission, San Luis Obispo Council of Governments, Regional Transit Authority, Air Pollution Control District and Integrated Waste Management Authority giving thorough, thoughtful and often insightful testimony on a multitude of relevant issues; and,

**WHEREAS**, Eric's advocacy over the years has positively influenced elected officials' decision-making on hundreds of issues; and

**WHEREAS**, Eric Greening is the embodiment of the tireless citizen activist--deeply rooted in his community. His love of the arts and of people gives everything he touches real warmth.
