**WHEREAS**, Dan has worked closely with a wide variety of allied professionals from federal, state and local agencies, including the FBI, the US Attorney, and the California Department of Justice, as well as the California District Attorneys Association (CDAA), and has served in a leadership role with a number of groups, including chair of the Suspected Abuse Response Team (SART) Advisory Board for many years; and

**WHEREAS**, Dan will be deeply missed by his colleagues, coworkers and friends throughout the state and county for his intelligence, wit, humor, and compassion for others, and he has been appreciated for his many years of commitment to the pursuit of justice and the rights of crime victims; and

**NOW THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF SUPERVISORS**, County of San Luis Obispo, State of California, that Assistant District Attorney Dan Hilford be hereby commended for his 39 years of dedication to the County and its mission;
