He also served as a delegate to the International Farm Youth Exchange Conference and Agricultural Tours in New Zealand, Australia, the Philippines, Taiwan, the British Isles and Sweden, and;

WHEREAS, Don is also a Life Member of the International Farm Youth Exchange Alumni where he served as a member of the National Board of Directors from 1992-94; and

WHEREAS, Don is Vice-Chairman of the Board of Directors and Founder of Heritage Oaks Bank, Paso Robles; and

WHEREAS, Don has been a member of the Paso Robles Rotary for 34 years and served as a past President; and

WHEREAS, Don has served as a member of the Pioneer Day Committee for 48 years, acting as Director and Chairman in 1980-81; and

WHEREAS, Don is also a member of the San Luis Obispo County Farm Bureau, California Association of Wine Growers, California and National Cattlemen's Association, Central Coast Wine Growers Association, and served on the Board of Directors for the Paso Robles Vintners & Growers Association; and

WHEREAS, Don has been a member of the Paso Robles Trail Riders for 30 years, volunteered for the Junior Livestock Auction for 47 years and has served as a Paso Robles Chamber Agricultural Tour Historian, Bus Captain and Past Chair; and

WHEREAS, Don has dedicated his time and service to the youth of our community as a 4-H Club Leader for over 20 years, receiving the State 4-H Alumni Award in 1991 and is currently serving on the School Advisory Committee for Saint Rose Catholic School; and

WHEREAS, Don was honored as Roblan of the Month in 1981 and received the Outstanding Rural Urban Service Award from the San Luis Obispo Rotary Club in 2010; and

WHEREAS, Don is a Charter Member of the Mid State Fair Heritage Foundation.
