RESOLUTION COMMENDING WAYNE HANSEN
IN RECOGNITION OF THIRTY FIVE YEARS OF
SERVICE WITH SAN LUIS OBISPO COUNTY

THE FOLLOWING RESOLUTION IS HEREBY OFFERED AND READ:

WHEREAS, Wayne Hansen has worked for the County of San Luis Obispo, since November 28, 1977, without interruption, encompassing 35 years of employment; and

WHEREAS, Wayne Hansen has worked throughout his career in Drug and Alcohol Services, starting out as an Alcohol Services Health Educator, then became an Alcohol Services Prevention Program Coordinator in July of 1985, then became a Prevention and Planning Supervisor in September of 1989, then became a Division Manager in September of 1993, then became a Health Care Analyst in December of 2000, and has served as an Administrative Services Officer II since July of 2006, in the Administrative Division of the Health Agency supporting the Drug and Alcohol Services Division; and

WHEREAS, Wayne is a very dedicated County employee whose priority is to serve the people in the community that suffer from drug and alcohol addiction. He works hard to do whatever it takes to secure the funding to ensure the County can provide treatment and prevention services for people who want to gain sobriety and maintain a drug-free life style; and

WHEREAS, Wayne is responsible for a significant number of Federal and State grants being awarded to the County which allowed Drug and Alcohol Services to develop award-winning prevention strategies as well as provide innovative treatment for individuals and families that are either involved in the Court system or seek services through other voluntary programs; and

WHEREAS, Wayne has successfully led coalitions that united many community interests in the cause of addiction prevention; including the creation of the Prevention Alliance focused on youth asset development and substance use education which spawned many community Youth Task Force groups, and the county's Tobacco Prevention Coalition which has been instrumental in affecting policy which reduces the negative impact of smoking on the Central Coast; and

WHEREAS, Wayne has over the many years provided leadership in the development of data collection and evaluation within the Agency reducing the reliance on and cost for outside consultants; and

WHEREAS, Wayne is a well-travelled expert in many fields, including gardening and a

gourmet cook, providing a positive guidance and spirit amongst his co-workers and the many community organizations he has supported over his many years with the County.

NOW THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF SUPERVISORS, County of San Luis Obispo, State of California, that Wayne, be and hereby is commended for his 35 years of dedication to the County mission;
