RESOLUTION COMMENDING DAVID W. POMEROY
IN RECOGNITION OF THIRTY YEARS OF
SERVICE WITH SAN LUIS OBISPO COUNTY

THE FOLLOWING RESOLUTION IS HEREBY OFFERED AND READ:

WHEREAS, David W. Pomeroy began working for the County of San Luis Obispo as a Deputy District Attorney on January 31, 1983; and

WHEREAS, Dave Pomeroy has handled a wide variety of assignments for the District Attorney's Office, including misdemeanor trials, preliminary hearings, child dependency cases, narcotics prosecutions, adult and child sexual assault cases, general felony trials, and acting as felony trials team leader; and

WHEREAS, Dave Pomeroy, since 1983, has been a thoughtful, reliable, dedicated, well-prepared and extremely effective prosecutor; and

WHEREAS, Dave Pomeroy has always been a strong "team player," regularly willing to assist colleagues with whom he works and to act as an instructional resource to outside law enforcement agencies and to the County Probation Department, the California District Attorneys Association, and Atascadero State Hospital, among others; and

WHEREAS, Dave Pomeroy has successfully handled some of the District Attorney's Office's most serious cases, including the murder cases of *People v. Fred Mazza* (1984), *People v. Cassandra Scott* (1988), *People v. James Bash* (1989), *People v. Allen Kness* (1999), *People v. Steven Padilla* (2007), *People v. Matthew Levine* (2009), *People v. Andrew Downs* (2012), and *People v. Robert Bradford* (1992), the first vehicular murder prosecution in our county; and

AND WHEREAS, Dave Pomeroy, in 2013, has been selected by the Pacific Southwest Region of the Anti-Defamation League to receive the prestigious Helene and Joseph Sherwood Prize for Combating Hate for his successful efforts in the 2012 prosecution of the *People v. Jason Kahn, et al.*, cross burning case.

NOW THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF SUPERVISORS, County of San Luis Obispo, State of California, that David W. Pomeroy, be and hereby is commended for her 30 years of dedication to the County mission;
