WHEREAS, Chuck's dedication to planning and to his community are illustrated by his many years of service on the City of San Luis Obispo's Architectural Review Commission and Planning Commission and by the tremendous amount of time he has devoted to lecturing at Cal Poly in City and Regional Planning ; and
