## **DISCUSSION**

Staff revised the attached Exhibit A (the Program Year 2013 Action Plan Funding Recommendations) after receiving final funding recommendations from the February 26, 2013 Arroyo Grande City Council meeting. The revisions also fix inadvertent errors in the original exhibit. These revisions are listed below:

1. Removing the "Code Enforcement" project under the City of Arroyo Grande and adding the "Façade Improvement" project under the "Public Facility" category and allocating \$10,000 in CDBG funds.
2. Adding a new project under the "Housing" category for the City of Atascadero called "New HVAC System at Shelter by the North County Women's Shelter & Resource Center" and allocating \$11,350 in CDBG funds.
3. Changing the name of the project under the "Public Facility" category for the SLO County Public Works to "Oceano Drainage Improvements on Hwy. 1 and 13th and Paso Robles Streets by SLO County Public Works".
4. Removing the Emergency Shelter Grant (ESG) column and its associated projects and adding a separate table for the ESG funding recommendations.
5. Merging "Special Urban Projects Funds" (SUPF) and "County of San Luis Obispo" columns and showing allocated funds with an asterisk.
