RESOLUTION RECOGNIZING COLONEL BARBARA A. NUISMER FOR  
HER SERVICE AS THE GARRISON COMMANDER AT CAMP ROBERTS  
AND TO THE CALIFORNIA ARMY NATIONAL GUARD**

The following resolution is hereby offered and read:

**WHEREAS**, Colonel Barbara A. Nuismer served from October 1, 2009 through March 3, 2013 as the Garrison Commander and Base Operation Manager at Camp Roberts Maneuver Training Center- Heavy, California Army National Guard. In this capacity Colonel Nuismer was responsible to the Commander of the California Army National Guard and for providing oversight for personnel management, maintenance, readiness, security, safety, budget operations and the supply discipline matters pertaining to the organization and operations of Camp Roberts; and

**WHEREAS**, Colonel Nuismer entered active military duty service with the rank of Private in 1975 and was honorably discharged as a Chief Warrant Officer 2 in 1984. During her active service she had tours in Germany and Korea. In 1985 she earned a commission through the Washington Military Academy and she held numerous assignments in the Washington Army National Guard; and

**WHEREAS**, her previous California Army National Guard assignments include: Maintenance Plans Officer, HQ, STARC; Director of Joint Logistics; Commander, Joint Task Force Vista; and Commander, 100th Troop Command; and

**WHEREAS**, Colonel Nuismer is a decorated officer; having earned many honors and medals, including the Meritorious Service Medal (3 Oak Leaf Clusters); the Army Commendation Medal (3 Oak Leaf Clusters); and the Army Achievement Medal (2 Oak Leaf Clusters); and

**WHEREAS**, Colonel Nuismer completed the United States Army War College at Carlisle Barracks, Pennsylvania, obtaining a Master of Science in Strategic Studies. She also holds a Bachelor of Science in Business Administration from City University, Bellevue, Washington and a Master of Arts in Occupational Therapy from the University of Puget Sound, Washington; and

**WHEREAS**, Colonel Nuismer represented the California Army National Guard for the Camp Roberts Joint Land Use Study and the Army Compatible Use Buffer Program. She also represented Camp Roberts at the San Miguel Community Services District and the San Miguel Advisory Council meetings. Colonel Nuismer is active in several service organizations in the North County area.

**NOW, THEREFORE, BE IT RESOLVED**, that the County of San Luis Obispo, Board of Supervisors, State of California, does hereby recognize Colonel Barbara A. Nuismer for her many

years of service to our Country, our County and our community, and wishes her well in her retirement.
