Mr. Cody Van Dorn, Department Administrator, gave an informational preview of the 2014 Parks and Golf Fees scheduled to take effect January 1, 2013. He answered Commissioner's questions along with **Mr. Larry Iaquinto**, Park Superintendent and **Mr. Josh Heptig**, Golf Superintendent.

9. **Deputy Director-Parks' Report.** This is the time set for the Deputy Director of Parks report.

Mr. Larry Iaquinto, Parks Administrator, speaking for the absent **Mr. Curtis Black**, Deputy Director-Parks, spoke on progress on the new reservations system which will go live June 5 or June 12; the success of the second annual Outdoor Discovery Festival at Lopez Lake; the success of bringing trout back to Lopez Lake, which will start next week; progress on tennis courts at Shandon; the Memorial to Those Lost at Sea at Cayucos Pier; progress on the closure of K Street in San Miguel; progress on signage on the Bob Jones trail; status on completed projects; construction on the Avila boardwalk; the Campeneros utilities upgrade at Lopez; and progress on the Santa Margarita Boating Camps. He answered Commissioner's questions.

10. **Approve letters of donation.** This is the time set for the Chairperson to acknowledge and accept any Letters of Donation received.

Vice Chairperson Nash-Karner accepted Letters of Donation from Shandon Valley Lions Club, \$7049.25 for free recreational swim programs; the San Miguel Lions Club, \$7020.00 for free recreational swim programs; SLOPOST, \$250 for the Outdoor Discovery Festival.
