SUBJECT: Submittal of a resolution establishing the 2013-14 special tax rate and confirming the per parcel special tax amount in Nipomo Lighting District, Zone E (Tract 1700, Los Pinos Estates). District 4.

RECOMMENDATION

It is our recommendation that your Honorable Board:

1. Approve the resolution confirming the 2013-14 Nipomo Lighting District, Zone E special tax rate of \$51.20 per Assessor Parcel Number.
2. Direct the Clerk to file the approved copy of the resolution with the County Auditor no later than August 10, 2013.

DISCUSSION

On August 3, 1999, the electorate in Nipomo Lighting District, Zone E voted for approval of a special tax with a maximum annual rate of \$40 and a 2% per year increase per Assessor's Parcel Number. Fiscal Year 2013-14 will be the fifteenth year that the tax is levied. No further consideration due to Proposition 218 is required.

In order to levy the tax during the 2013-14 fiscal year, your Honorable Board must pass a Resolution establishing the 2013-14 rate, and confirming the amount of the special tax levied on each parcel of real property. The special tax is authorized per Section 53978 of the Government Code.

OTHER AGENCY INVOLVEMENT/IMPACT

County Counsel has reviewed the subject Resolution and approved it as to legal form and effect. The Offices of the Auditor-Controller and Treasurer/Tax Collector are involved in the process of collecting special taxes on the property tax bills.

FINANCIAL CONSIDERATIONS

The recommended action will generate approximately \$2,000 in revenue which, other than interest, will be the sole source of 2013-14 revenue in Nipomo Lighting District, Zone E.

RESULTS

The recommended action will result in the continuation of the County's past practice of collecting certain special district's special assessments on the property tax bills. The revenue funds the cost of the health and safety issues that help to maintain the quality of life in these communities.
