**WHEREAS**, Cayucos Community Groups including: Lions, Lionesses, Negranti Construction, Cayucos Chamber of Commerce, Rotary, Cayucos Visitor Alliance, Seniors Citizens of Cayucos, Cayucos Garden Club and Cayucos Citizens Advisory Council, stepped forward to provide cash and in-kind donations to provide new play equipment and fund its installation on Cayucos Beach for the benefit and enjoyment of the entire community for generations to come, and

**WHEREAS**, that new play equipment was installed at Cayucos Beach just south of Cayucos Pier on April 6, 2013, and

**WHEREAS**, Cayucos Rotary has completed an Adopt A Park agreement to provide ongoing care for the Cayucos Beach Play equipment, and

**WHEREAS**, special recognition should go to Greg Bettencourt, and Parks staff for moving this project forward.
