RESOLUTION OF THE BOARD OF SUPERVISORS FOR THE COUNTY OF SAN LUIS OBISPO  
AUTHORIZING THE SURPLUS AND DONATION OF A USED CONSTRUCTION TRAILER TO  
THE DANA ADOBE NIPOMO AMIGOS

The following resolution is hereby offered and read:

WHEREAS, the County of San Luis Obispo currently owns a used construction trailer; and

WHEREAS, the trailer is no longer required for County use; and

WHEREAS, the County Board of Supervisors has the authority under Government Code Section 25372 to declare County property surplus and to donate County surplus property to, among others, a non-profit organization exempt from taxation pursuant to 26 U.S.C. Section 501(c)(3) ("exempt non-profit organization") and which is organized for the care, teaching, or training of children or developmentally disabled children, or for the care, teaching, or training of Native Americans.; and

WHEREAS, Dana Adobe Nipomo Amigos, Inc. is an exempt non-profit organization that is organized for the care, teaching, or training of Native Americans;

WHEREAS, Dana Adobe Nipomo Amigos has stated the need for the construction trailer for the purpose of converting it to two Americans with Disabilities Act (ADA) compliant restrooms for the use of visitors at Rancho Nipomo Dana Adobe; and

WHEREAS, it is in the best interest of the public to surplus and donate the trailer to the Dana Adobe Nipomo Amigos.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, as follows:

1. Pursuant to Government Code Section 25372, the Chairperson of the Board of Supervisors hereby declares as surplus property the trailer, designated as #8800 and asset #V0000019, located at the County Operations Center at 1475 Kansas Avenue in San Luis Obispo, "as-is",

with all faults and without any warranties as to the trailer's condition, usefulness, or otherwise;

2. The Board of Supervisors hereby donates the surplus trailer to the Dana Adobe Nipomo Amigos for the support of the conversion to two ADA compliant restrooms for the use of visitors at the Dana Adobe, "as-is," with all faults and without any warranties;
3. The County Purchasing Agent is authorized to take such further actions as required, if any, to complete the donation to the Dana Adobe Nipomo Amigos.
