**RESOLUTION ACCEPTING CERTAIN ROADS
INTO THE COUNTY ROAD SYSTEM
COUNTY ROAD NOs. 5325, 5326**

The following resolution is hereby offered and read:

WHEREAS, the County of San Luis Obispo, State of California, has been duly requested to accept a certain offer to dedicate certain roads into the maintained road system in said County; and

WHEREAS, Limestone Way and Blue Rock Road are designated on the map of the Marquita Industrial Park in the community of Templeton, as filed in Tract 2475 in Book 27 of Maps, at Page(s) 35 through 37 inclusive in the Office of the County Recorder of said County; and

WHEREAS, said roads have been constructed and inspected with the development of Tract 2475 “Marquita Industrial Park”; and

WHEREAS, The County Surveyor, by letter, has duly recommended that the Honorable Board of Supervisors accept the offer of dedication for public use of Limestone Way and Blue Rock Road, as shown on Tract 2475.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, by the Board of Supervisors of the County of San Luis Obispo, State of California:

1. That the offer to dedicate 0.181 miles of Limestone Way, County Road No. 5325 and 0.080 miles of Blue Rock Road, County Road No. 5326 as shown on Tract 2475 as filed in Book 27 of Maps, at Page 35 through 37 inclusive in the Office of the County Recorder are hereby accepted into and made a part of the County Road System, to be maintained in kind, and shall and do constitute County highways in the County of San Luis Obispo.
2. That the County Clerk be and hereby is authorized and directed to record a copy of the Resolution in the Office of the County Recorder of the County of San Luis Obispo.
3. Said offer of dedication is offered by Michael C. and Cathleen M. English.
