SUBJECT: Request to approve an agreement in the amount of \$100,000 with the Food Bank Coalition of San Luis Obispo for grant funds through Fund Center 106 – Contributions to Other Agencies for Fiscal Year 2013-14.

RECOMMENDATION

It is recommended that the Board approve the agreement with the Food Bank Coalition of San Luis Obispo County in the amount of \$100,000 from Fund Center 106 – Contributions to Other Agencies grant funds.

DISCUSSION

During the 2013-14 Budget Hearings, your Board approved grant funding for a variety of organizations in Fund Center 106 – Contribution to Other Agencies. The Food Bank Coalition of San Luis Obispo County was approved for grant funding in the amount of \$100,000 from the Community Based Organization category. The funds will be used by the Food Bank in support of their various programs, including but not limited to, the Senior Brown Bag, Harvest Bag and CalFresh outreach programs as well as general food distribution to those in need.

OTHER AGENCY INVOLVEMENT/IMPACT

Various non-profit organizations are included in the list of grant recipients. County Counsel has reviewed and signed the agreements.

FINANCIAL CONSIDERATIONS

During the budget process, your Board approved a total of \$1.8 million in grant funding for the Fund Center's various grant programs (district community projects, community based organizations, preventive health and other agencies grants). The Food Bank Coalition of San Luis Obispo County was approved for \$100,000 grant.

RESULTS

This financial support will assist non-profit agencies in providing essential services to County residents that are not provided by the County or provide a service that contributes to the health, economic, and social well-being of County residents. Each organization is required to provide a scope of work with details relating to meaningful measurable results. Specifically, as noted above, the funds will be used by the Food Bank in support of their various programs, including but not limited to, the Senior Brown Bag, Harvest Bag and CalFresh outreach programs as well as general food distribution to those in need.

A total of 4,298,703 pounds of food were distributed by the Food Bank in FY 2012-13 through programs assisted by the CBO grant, a 3.3% increase from FY 2011-12. Complete results for FY 2012-13 can be found attached to this report.
