**RESOLUTION ACCEPTING CERTAIN ROADS
INTO THE COUNTY ROAD SYSTEM
COUNTY ROAD NOS.: 1531, 1532, 1533, 1534**

The following resolution is hereby offered and read:

WHEREAS, the County of San Luis Obispo, State of California has been duly requested to accept the certain offers of dedication for roads Santa Maria Vista, Vista Del Rio, Vista Del Sol, and Vista Del Pueblo as described the attached Exhibit "A" (herein afterwards referred to as "Subject Roads") into the County Road System; and

WHEREAS, the Subject Roads are designated on the map of Tract 1802 Phase 2 filed in Book 25 of Maps at Pages 36-46 inclusive; the map of Tract 1856 Phase 1 filed in Book 20 of Maps at Pages 12 and 13; and the map of Tract 1856 Phase 2 filed in Book 25 of Maps at Pages 47-50 inclusive, all in the Office of the County Recorder of said County; and

WHEREAS, said roads have been constructed and inspected with the development of said Tract 1802 Phase 2 and said Tract 1856 Phases 1 and 2; and

WHEREAS, the County Surveyor, by letter, has duly recommended that the Board of Supervisors accept the offers of dedication for public use of the Subject Roads as described herein.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, by the Board of Supervisors of the County of San Luis Obispo, State of California:

1. That those certain offers of dedication for the Subject Roads described in the attached Exhibit "A" are hereby accepted into and made a part of the County Road System, to be maintained in kind, and shall and do constitute County highways in the County of San Luis Obispo.
2. That the County Clerk be and hereby is authorized and directed to record a copy of the resolution in the Office of the County Recorder of the County of San Luis Obispo.
3. Said offers of dedication are made by TRINCON Inc. and Maria Vista Estates, a California General Partnership.
