## **RECOMMENDATION**

## **DISCUSSION**

The City of Paso Robles is requesting grant funds to offset expenses associated with holding free public events throughout the year long 125<sup>th</sup> anniversary extravaganza. Events include fireworks in the Park, a city-wide birthday party, Pioneer Day Family Day, and end of the year fireworks. The year-long celebration will promote the City's rich heritage and generate renewed interest in its preservation for the enjoyment of future generations. The \$2,000 in County funds will be used towards expenses associated with holding the four events noted above free to the public.

## **OTHER AGENCY INVOLVEMENT/IMPACT**

City of Paso Robles will be coordinating the various city-wide events in celebration of their 125<sup>th</sup> year.

## **FINANCIAL CONSIDERATIONS**

Funding in the amount of \$2,000 will be allocated from Community Project Funds – Fund Center #106 to the City of Paso Robles.

## **RESULTS**

The funds will be used towards expenses associated with holding free public events in celebration of the City of Paso Robles' 125<sup>th</sup> anniversary. The City, along with local businesses, service organizations, educational and historical organizations will create events that showcase the City's rich heritage. These events will engage and educate the citizens and tourists who attend them.
