SUBJECT: Request to approve the appointment of Angelo Arevalos, Jr. to a labor partner seat on the San Luis Obispo County Workforce Investment Board for a term expiring on June 30, 2015.

## **RECOMMENDATION**

It is recommended that the Board approve the appointment of Angelo Arevalos, Jr. to a labor partner seat on the San Luis Obispo County Workforce Investment Board for a term expiring on June 30, 2015.

## **DISCUSSION**

The Workforce Investment Act (WIA), signed into law August 7, 1998, mandates that the Chief Local Elected Official (CLEO) designate a Local Workforce Investment Board (WIB) to set policy direction and to oversee WIA funded operations. The WIA mandates that the WIB maintain a business majority and its composition include representatives from business, local educational entities, labor groups, community based organizations, economic development agencies, and each of the One-Stop Career Center partners, as well as others that your Board determines to be appropriate. The WIB is a 35-member body with several vacancies including five (5) business sector, one (1) economic development, and three (3) labor seats. The WIB is requesting to fill a labor seat at this time. The WIB is actively recruiting to fill all remaining vacancies by June 30, 2014.

The WIA requires representatives of labor organizations, for a local area in which employees are represented by labor organizations, nominated by local labor federations. Angelo Arevalos, Jr. is recommended for appointment to fill a vacant labor seat. Mr. Arevalos is President/Business Agent for Laborers Union Local 220, which spans Kern, Santa Barbara, and San Luis Obispo counties. Mr. Arevalos has extensive knowledge of the construction industry and its local talent needs. Mr. Arevalos' expertise may inform the WIB's approach to developing training and focus on improving the soft skills of job seekers.
