RESOLUTION AMENDING EMPLOYEE PENSION CONTRIBUTION RATES FOR  
EMPLOYEES IN THE ASSOCIATION OF SAN LUIS OBISPO COUNTY DEPUTY SHERIFFS  
(ASLOCDS), SWORN LAW ENFORCEMENT SUPERVISORY UNIT (BU28) AND  
APPROVING AMENDMENTS TO THE SAN LUIS OBISPO COUNTY EMPLOYEES  
RETIREMENT PLAN APPENDICES

The following resolution is hereby offered and read:

WHEREAS, the Association of San Luis Obispo County Deputy Sheriffs (hereinafter referred to as “ASLOCDS”) is recognized as the exclusive representative of employees in the Sworn Law Enforcement Supervisory Unit BU28; and

WHEREAS, pursuant to Article 7.1.4 of the amended ASLOCDS Memorandum of Understanding (MOU), dated June 19, 2012, it was agreed that any pension rate increase determined by the Pension Trust Board shall be shared between the parties 50/50; and

WHEREAS, amendments to the San Luis Obispo County Employees Retirement Plan include an amendment to Appendix B – Safety Members Contribution Rates and Appendix B Tier 2 – Safety Members Contribution Rates; and

WHEREAS, it is in the best interest of the County of San Luis Obispo, per contractual obligation, that the Board of Supervisors approve and direct the Chair to sign revisions to the San Luis Obispo County Employees Retirement Plan, attached hereto as Appendix B – Safety Members Contribution Rates and Appendix B Tier 2 – Safety Members Contribution Rates.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California as follows:

1. That the recitals set forth hereinabove are true, correct, valid and incorporated herein; and
2. That effective the pay period that includes January 1, 2014, “Safety” members in Bargaining Unit 28 shall receive an employee pension rate increase of 0.60% resulting from the Pension Trust’s 2012 actuarial study (report dated January 1, 2013). The

County's appropriation rate shall also increase by 0.61%; and

3. That the San Luis Obispo County Employees Retirement Plan is hereby amended to include the revisions to Appendix B – Safety Members Contribution Rates (B.S.28.S) and Appendix B Tier 2 – Safety Members Contribution Rates (T2-B.S.28.S); and
4. That Appendix B – Safety Members Contribution Rates (B.S.28.S) and Appendix B Tier 2 – Safety Members Contribution Rates (T2-B.S.28.S) to the San Luis Obispo County Employees Retirement Plan be revised.
