RECOMMENDATION

It is recommended that the Board approve the attached resolution to accept the offer of dedication for a portion of Vista Del Rio, County Road No. 1532 as described in Document number 2004-016354.

DISCUSSION

Vista Del Rio, County Road No. 1532, measuring 0.546 mile in length southwesterly from Hutton Road was accepted into the county maintained road system by Resolution 2013-208 approved by your Board on August 20, 2013. Subsequent to that action it has been discovered that a certain offer of dedication contained in document number 2004-016354 as recorded on March 2, 2004, in the Office of the County Recorder was not included within Exhibit "A" of said resolution. We are recommending that your Board now accept this offer of dedication to complete the acceptance of the entire right of way width for said Vista Del Rio as intended by the August 20, 2013 action.

OTHER AGENCY INVOLVEMENT/IMPACT

There is no other agency involvement in this matter.

FINANCIAL CONSIDERATIONS

There is no cost associated with this action since there is no additional length of new road being accepted into the County road system.

RESULTS

The result of this action will be to accept the complete right of way area of the subject road into the County maintained road system and ensure that the necessary public right of way to maintain this road has been secured to serve the public's needs in the future.
