SUBJECT: Request to approve the appointment of James Patterson to the Homeless Services Oversight Council (HSOC). All Districts.

## **RECOMMENDATION**

It is recommended that the Board of Supervisors approve the appointment of James Patterson to the Homeless Services Oversight Council (HSOC) for a term expiring on January 1, 2016. Jim Patterson will fill the vacancy left by Tina Salter.

## **DISCUSSION**

Due to the resignation of an HSOC representative from the El Camino Homeless Organization, there is currently a vacancy for a Nonprofit Service Provider seat on the HSOC.

James Patterson has a long history of involvement with homeless programs and the HSOC. He currently serves on the boards of the El Camino Homeless Organization and the Community LINK in Atascadero. From 2005-2013, Mr. Patterson served on the County Board of Supervisors. While a County Supervisor, he served as the Chair of HSOC and was on the committee that developed the County's 10-Year Plan to End Homelessness and created the HSOC. He has also served on the board of the Community Action Partnership of San Luis Obispo (CAPSLO) and is currently a member of the HSOC Housing Committee. Therefore, James Patterson is recommended for appointment to a Nonprofit Service Provider seat on the HSOC.

## **OTHER AGENCY INVOLVEMENT/IMPACT**

The HSOC voted to recommend the appointment of James Patterson at its January 15, 2014 meeting. The Clerk-Recorder's office has confirmed the terms of office are accurate and that the posting requirements have been met.

## **FINANCIAL CONSIDERATIONS**

There are no financial considerations associated with this appointment.

## **RESULTS**

The immediate results of the action requested today will be to strengthen the HSOC by adding the expertise of James Patterson.
