RESOLUTION APPROVING AND AUTHORIZING SUBMITTAL OF THE URBAN COUNTY OF SAN LUIS OBISPO PROGRAM YEAR 2014 ACTION PLAN UNDER THE COUNTY OF SAN LUIS OBISPO'S 2010 CONSOLIDATED PLAN FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), HOME INVESTMENT PARTNERSHIPS (HOME), AND EMERGENCY SOLUTIONS GRANTS (ESG) PROGRAMS

The following resolution is hereby offered and read:

WHEREAS, the County of San Luis Obispo sees a need to promote and protect decent and suitable housing and community development opportunities for the residents of this county; and

WHEREAS, the County of San Luis Obispo, a political subdivision of the State of California, wishes to apply for and receive 2014 allocations of funds through the Community Development Block Grant (hereinafter referred to as "CDBG"), Home Investment Partnerships Program (hereinafter referred to as "HOME"), and Emergency Solutions Grants (hereinafter referred to as "ESG") programs; and

WHEREAS, the U.S. Department of Housing and Urban Development (hereinafter referred to as "HUD") has designated the County of San Luis Obispo, and the cities of Arroyo Grande, Atascadero, Morro Bay, Paso Robles, and San Luis Obispo, as an "Urban County" eligible to receive annual CDBG, HOME, and ESG allocations directly from HUD to be used in accordance with the federal statutes and regulations; and

WHEREAS, the Urban County of San Luis Obispo wishes to submit to HUD the Program Year 2014 Action Plan as required by 24 CFR Part 91 of the federal regulations to establish the activities funded with the 2014 CDBG, HOME, and ESG programs; and

NOW, THEREFORE BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, as follows:

1. That the recitals set forth herein above are true, correct and valid.
2. The County of San Luis Obispo approves the Program Year 2014 Action Plan and authorizes the submission of t the 2014 Action Plan to HUD to establish the identified activities funded by CDBG, HOME, and ESG programs.
3. If HUD approves the Program Year 2014 Action Plan, the County of San Luis Obispo agrees to use the CDBG, HOME, and ESG funds for eligible activities in accordance with the applicable federal statutes and regulations.
4. The County of San Luis Obispo authorizes the Director of the Department of Planning and Building to execute the 2014 Action Plan, Applications for Federal Assistance, certifications, the Standard Agreement and all other program related agreements or documents required by HUD for participation in the CDBG, HOME, and ESG programs.
5. The County of San Luis Obispo authorizes the Director of Planning and Building to transmit three certified copies of this resolution and the Urban County of San Luis Obispo Program Year 2014 Action Plan to HUD, and to make minor modifications to the Consolidated Plan which do not constitute amendments under applicable federal regulations.
