Board of Supervisors' Resolution authorizing the county to enter into a contract with the California Victim Compensation and Government Claims Board for a Revolving Fund for Crime Victim Compensation Claims

The following resolution is hereby offered and read:

WHEREAS, the County of San Luis Obispo Board of Supervisors previously entered into an agreement with the Victim Compensation and Government Claims Board (hereafter referred to as the "VCGCB") and desires to continue a Revolving Fund to assist applicants who have an immediate need for payment of an expense (i.e. funeral/burial, relocation, and crime scene clean-up expenses), where the applicant would suffer a substantial hardship without such emergency payment; and

WHEREAS, the VCGCB has selected the San Luis Obispo County District Attorney's Victim/Witness Assistance Center (hereafter referred to as "Center") to receive "joint powers" monies for the purpose of victim compensation claim verification annually since 1989, and;

WHEREAS, the County of San Luis Obispo desires to enter into an agreement with VCGCB from July 1, 2014 through June 30, 2017 to expedite the payment of emergency funeral/burial, relocation and crime scene clean-up on behalf of victims using a revolving fund, as empowered by Government Code 13950 et seq., and;

WHEREAS, the VCGCB has previously advanced \$60,000 as authorized under Government Code Section 6504, to pay qualifying claims for the period of July 1, 2014 through June 30, 2017; and

WHEREAS, the District Attorney's Victim/Witness Assistance Center shall exercise appropriate internal records over the issuance of funds and requests for reimbursement of funds to replenish the account;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, that the District Attorney of the County of San Luis Obispo is authorized, on its behalf, to execute on behalf of the Board of Supervisors the Contract including any extensions or amendments thereof.
