**RESOLUTION COMMENDING INGRID WARREN
IN RECOGNITION OF THIRTY-THREE YEARS OF SERVICE
WITH SAN LUIS OBISPO COUNTY**

THE FOLLOWING RESOLUTION IS HEREBY OFFERED AND READ:

WHEREAS, Ingrid Warren joined the County on September 20, 1980 and spent 18 years in the Assessor's Office, starting as an Appraiser Trainee and working her way up to an Appraiser III, specializing in the assessment of agricultural properties; and,

WHEREAS, Ingrid Warren made the transition to General Services in 1999 as an Associate Real Property Agent and has spent 15 years specializing in commercial real estate leases for County departments; and,

WHEREAS, Ingrid has also worked on some of the County's significant real estate acquisitions, such as the new Cambria Library in 2009 and the new Atascadero Library, Assessor, Planning & Building, and Clerk Recorder's offices in 2010; and

WHEREAS, Ingrid's fairness, intelligence, and sincerity in working with property owners has helped the County to maintain an excellent reputation in real estate matters; and

WHEREAS, Ingrid is the only person to have ever brought in a live calf to display in the lobby of the County Government Center in honor of the Agriculture Commissioner's Annual Report; and

WHEREAS, Ingrid's husband, Richard, also worked for the County of San Luis Obispo in the Department of Public Works, and together they have commuted to work from Cayucos almost every day over the past 33 years; and

WHEREAS, Ingrid's strong work ethic and knowledge of the land came, in part, from

living with her husband and their three children on a 330 acre ranch, where her daily routine was to get up early, feed the dogs, goats, sheep, horses, chickens, cattle, and chinchilla before coming to work at 8:00 AM each day; and

WHEREAS, in spite of her harrowing schedule, Ingrid still had the energy to be a top-rated national competitor in the triathlon, and continues to compete to this day; and

WHEREAS, Ingrid Warren will be missed by her co-workers and by all the employees she has assisted with their real property needs throughout virtually every department of the County.
