RESOLUTION PROVIDING FOR A CREDIT/REBATE IN COUNTY SERVICE AREA NO. 1A (GALAXY PARK, TRACT 1898, NIPOMO) PARKWAY FACILITIES SERVICES

The following resolution is now offered and read:

WHEREAS, the Board of Supervisors established the service charge for Parkway Facilities Services in County Service Area 1A for Fiscal Year 2014-15, on June 17, 2014, in the amount of \$84 per parcel per year; and

WHEREAS, the parkway facilities service charge for County Service Area 1A, Tract 1898 was initially established on April 12, 1994, at a rate of \$7 per month; and

WHEREAS, to fund the CSA 1A budget for Fiscal Year 2014-15, it is not necessary to collect the entire amount of service charges previously established; and

WHEREAS, a temporary credit/rebate of a portion of the service charge established on June 4, 2013, is appropriate for Fiscal Year 2014-15 in the amount of \$20 per parcel; and

WHEREAS, such temporary credit/rebate shall be only effective for 2014-15 and shall not decrease the service charge established on June 17, 2014; and

WHEREAS, Exhibit "A", which is attached hereto and incorporated herein by reference as though here fully set forth, represents the credit/rebate, for each parcel in CSA 1A for the 2014-15 fiscal year; and

WHEREAS, it is in the public interest that the credit/rebate be adopted solely for Fiscal Year 2014-15.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, as follows:

That this annual service charge credit/rebate in County Service Area No. 1A (Galaxy Park, Tract 1898, Nipomo), pertaining to Parkway Facilities is hereby established for the 2014-15 fiscal year as shown in the report which is attached hereto, marked Exhibit "A", and incorporated herein by reference as though here fully set forth.
