SUBJECT: Request to set a hearing to consider the Temporary Commercial Outdoor Entertainment License Application for "Sunset SAVOR The Central Coast." Hearing date set for August 19, 2014. Exempt from the California Environmental Quality Act (CEQA). District 5.

RECOMMENDATION

It is recommended that the Board set a public hearing on August 19, 2014, for consideration of the Temporary Commercial Outdoor Entertainment License Application for the event "Sunset SAVOR The Central Coast," to be held at Santa Margarita Ranch on September 27 and 28, 2014.

DISCUSSION

Pursuant to County Ordinance Title 6, Chapter 6.56, "Visit San Luis Obispo County" has submitted Temporary Commercial Outdoor Entertainment License application documents for the event, "Sunset SAVOR the Central Coast," (Hereafter, SAVOR) to be held on September 27 and 28, 2014, at Santa Margarita Ranch. The ordinance requires a public hearing.

Although the SAVOR event is scheduled for September 25 - 28, only the events scheduled for September 27 and 28 are anticipated to have attendance over 3,000. Accordingly, only the events of September 27 and 28 are subject to the requirements of Chapter 6.56 of the County Ordinance.

Additionally, although the SAVOR event has taken place at the Santa Margarita Ranch location over the prior four years, this is the first year where the applicant is seeking approval for attendance of more than 3,000. As stated above, only events with attendance of 3,000 or more are required to apply for a license under Chapter 6.56 of the County Ordinance.

The public hearing will be noticed by the County Clerk as described in the Other Agency Involvement section, below. This will include mailing notice to the property owners within 500 feet of the parcels identified for the proposed use.

At the public hearing, your Board will be requested to consider testimony and other evidence, to approve, approve with conditions, or deny the application. Under County Ordinance Title 6, Chapter 6.56, a public hearing must be held within 30 days of receipt of a complete Application for a Temporary Commercial Outdoor Entertainment License.

OTHER AGENCY INVOLVEMENT

The application documents have been reviewed by County Counsel as to form. The County Clerk is responsible for giving written and published notice of the hearing. Written notice and copies of the application package have been provided to the Sheriff's Department, Health Department, Public Works, Planning Department, and Cal Fire. The noticed departments will be responsible to investigate the matter and report in writing to your Honorable Board not later than the time set for the hearing on August 19, 2014.

FINANCIAL CONSIDERATIONS

The applicant has paid a non-refundable application fee of one hundred dollars (\$100.00) plus a two hundred and fifty dollars (\$250.00) per day fee for the two day event.

RESULTS

Approval of this recommendation will result in a public hearing being set for August 19, 2014, for your Board to hear public comments, department recommendations, other testimony, and to determine a final outcome on the application
