

SHA/STP COOPERATIVE AGREEMENT
Amendment No. 7 to Agreement No. SLOCO-STL-01

THIS AGREEMENT is between the San Luis Obispo Council of Governments, referred to herein as “SLOCOG”, and the

County of San Luis Obispo
a municipal corporation and
political subdivision of the
State of California, referred
to herein as the “COUNTY”.

WHEREAS, SLOCOG and the COUNTY are authorized, pursuant to federal requirements of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users and Moving Head for Progress in the 21st Century , in addition to State Statutes enacted by SB 45 (1997), to enter into a Cooperative Agreement for any transportation purpose within the COUNTY; and

WHEREAS, the COUNTY of San Luis Obispo and the San Luis Obispo Council of Governments entered into Agreement No. SLOCO-STL-01 (“Agreement”) on September 26, 2006 and

WHEREAS, the Amendments #1 and #2 were made on March 23, 2007 and

WHEREAS, the Amendment #3 was made on October 10, 2009 and

WHEREAS, the Amendment #4 was made on April 14, 2010 and

WHEREAS, the Amendment #5 was made on May 5, 2012 and

WHEREAS, the Amendment #6 was made on May 20, 2014 and

WHEREAS, the Agreement is being modified by this Amendment #7 to reflect SLOCOG Board programming actions on December 4, 2013 and April 2, 2014, to modify the COUNTY’s State Highway Account/ Surface Transportation Program (SHA/STP) program of projects, and

NOW, THEREFORE, the parties mutually agree as follows:

1. That Agreement No. SLOCO-STL-01 is hereby amended by adding the programming amounts of SHA/STP project funding as identified in Table 1 (attached hereto and incorporated herein by this reference).
2. That reimbursement of invoices should be based on the estimates provided by COUNTY and approved by the SLOCOG Board on December 4, 2013, and April 2, 2014
3. That SLOCOG, as grantor of these funds, be recognized in all promotion of the projects in this Amendment. COUNTY shall include the recognition of SLOCOG in all project branding, signage, press releases, and other marketing materials related to the project.

4. That the remaining terms and conditions of the original Agreement SLOCO-STL-01 shall remain in full force and effect unless otherwise amended per agreement.


