RESOLUTION APPROVING THE REQUEST BY THE CAMBRIA COMMUNITY SERVICES DISTRICT TO WAIVE PERMIT PROCESSING FEES FOR A DEVELOPMENT PLAN/COASTAL DEVELOPMENT PERMIT (DRC2013-00112) FOR THE CAMBRIA EMERGENCY WATER SUPPLY PROJECT

The following resolution is now offered and read:

WHEREAS, the Cambria Community Services District has requested a waiver of the land use permit fees for a Development Plan/Coastal Development Permit (DRC2013-00112) for the Cambria Emergency Water Supply Project.

WHEREAS, as set forth in Footnote 4.e of the Department of Planning and Building Fee Schedule, the request of the Cambria Community Services District for waiver of the land use permit fees for a Development Plan/ Coastal Development Permit (DRC2013-00112) for the Cambria Emergency Water Supply Project must be heard and decided by the Board of Supervisors of the County of San Luis Obispo (hereinafter referred to as the Board of Supervisors); and

WHEREAS, a public hearing was duly noticed and conducted by the Board of Supervisors on September 23, 2014, and a determination and decision was made on September 23, 2014; and

WHEREAS, at said hearing, the Board of Supervisors heard and received all oral and written protests, objections, and evidence, which were made, presented, or filed, and all persons present were given the opportunity to hear and be heard in respect to any matter relating to said waiver request; and

WHEREAS, the Board of Supervisors has duly considered the request and finds that the request for waiver of land use permit fees should be granted subject to the findings set forth below.
