SUBJECT: Submittal of a resolution authorizing execution of notice of completion and acceptance for the Collection System Areas B & C Contract (W.A. Rasic Construction Company, Inc.) for the Los Osos Wastewater Project, Los Osos. District 2.

RECOMMENDATION

It is recommended that the Board adopt the attached resolution, which authorizes the execution and acceptance of a Notice of Completion for the construction of the Los Osos Wastewater Project, Collection System Areas B & C, Los Osos, CA. Contract No. 300448.08.01.BC.

DISCUSSION

On September 20, 2006, then California State Governor Arnold Schwarzenegger signed Assembly Bill 2701 (Blakeslee) which allowed the County, at the Board's discretion, to assume responsibility for the development of a wastewater project in the community of Los Osos. After the County had secured all necessary permits and funding for construction of the project, bids were solicited for the collection system contracts in spring of 2012.

On July 10, 2012, your Board awarded the Collection System Areas B & C Contract to W.A. Rasic Construction Company, Inc. (W.A. Rasic), the lowest responsive and responsible bidder on this contract. A Notice to Proceed was given to W.A. Rasic, on September 4, 2012, authorizing work to commence on this contract. Work continued on this contract through August 30, 2014, when W.A. Rasic reached final completion. Work on other project contracts is ongoing and will continue through 2016 when the project will be ready for start-up and connection of sewer laterals from individual properties.

The Project Engineer has determined that W.A. Rasic has completed all its work and its obligations within the time allotted for, and under the terms of the Contract Documents for this contract. It is now necessary to record the Notice of Completion for this contract, which will establish the deadline for which liens can be filed by subcontractors against the prime contractor.

OTHER AGENCY INVOLVEMENT/IMPACT

The U.S. Department of Agriculture (USDA) and State Water Board are jointly financing the Project and provided oversight of engineering and consulting agreements. USDA has also provided oversight on change orders and progress payment applications from the contractor during construction. Numerous other federal, state and local agencies are involved with the project. County Counsel is providing legal guidance on all aspects of the project.

FINANCIAL CONSIDERATIONS

The Collection System Areas B & C Contract is part of the multi-year Los Osos Wastewater Project (WBS 300448), which has a total project budget of \$183.4 million. The cost of the Collection System Areas B & C Contract is \$31,709,286.04 as of final completion. There are currently no pending claims or disputes.

A final report of actual project costs will be filed with the clerk after any and all claims, disputes and adjustments have been resolved. We do not anticipate the final project cost to differ materially from the current estimated total.

RESULTS

With approval of the recommended action, your Board will cause the legal Notice of Completion for this construction contract to be recorded. Completion of this contract is continued progress toward a functioning wastewater project and also helps the County in achieving its goal of providing a safe, healthy and well governed community.
