RECOMMENDATION

It is recommended that the Board introduce the ordinance in Attachment 1 and direct the Clerk to set for public hearing and action on November 25, 2014.

DISCUSSION

This ordinance is being introduced on your November 4, 2014 agenda in order to hold a public hearing and take action at your November 25, 2014 meeting.

The following ordinance is recommended for introduction today for hearing on November 25, 2014:

A request by the County of San Luis Obispo to amend Title 2 of the San Luis Obispo County Code to clarify that the Board of Supervisors is designated as the planning agency for the purpose of issuing conformity reports pursuant to Government Code sections 65401 and 65403.

County File Number: LRP 2014-00009

Supervisorial District: All

This amendment will clarify that only the Board of Supervisors needs to find the Capital Improvement Program consistent with the County's General Plan. The existing language of the code is unclear.

OTHER AGENCY INVOLVEMENT/IMPACT

FINANCIAL CONSIDERATIONS

No financial impacts to the current county budget.

RESULTS

Introduction of these amendments today will allow them to be heard on November 25, 2014 and become effective 30 days later.
