

Exhibit A

Amendments to the Traffic Regulation Code
County of San Luis Obispo

The following new sections are added to Chapter 15 of the San Luis Obispo County Traffic Regulation Code:

15.215.219 Juniper Street at Mary Avenue, Nipomo

The easterly and westerly intersections of Juniper Street (County Road No. 1033) with Mary Avenue (County Road No. 1302) are designated as stop intersections, and stop signs shall be erected at or near the entrance thereto.

15.219.183 Main Street at Ramada Drive, Templeton

The easterly intersection of Main Street (County Road No. 5186) with Ramada Drive (County Road No. 5201) is designated as stop intersection and a stop sign shall be erected at or near the entrance thereto.
