RESOLUTION ESTABLISHING CHANGES TO THE TRAFFIC REGULATION CODES FOR SPEED LIMITS ON SOUTH BAY BOULEVARD IN THE COMMUNITY OF LOS OSOS; AND MAIN STREET IN THE COMMUNITY OF TEMPLETON

Exhibit A

Amendments to the Traffic Regulation Code
County of San Luis Obispo

The following new sections are added to Chapter 15 of the San Luis Obispo County Traffic Regulation Code:

15.08.380 Main Street, Templeton

The speed limit shall be thirty-five miles per hour on Main Street (County Road No. 5186) from a point 200 feet north of First Street (County Road No. 5193) to River Run Road (County Road No. 4378).

15.14.090 South Bay Boulevard, Los Osos

The speed limit shall be fifty miles per hour on South Bay Boulevard (County Road No. 3125) from Santa Ysabel Avenue (County Road No. 3126) to Los Osos Valley Road (County Road No. 2088).

The following sections are amended in Chapter 15 of the San Luis Obispo County Traffic Regulation Code:

15.12.143 Main Street, Templeton

The speed limit shall be forty-five miles per hour on Main Street (County Road No. 5186) from River Run Road (County Road No. 4378) to Ramada Drive (County Road No. 5201).
