**RESOLUTION COMMENDING DANA LILLEY
UPON HIS RETIREMENT AFTER TWENTY NINE YEARS OF SERVICE
WITH THE DEPARTMENT OF PLANNING AND BUILDING**

The following resolution is now offered and read:

WHEREAS, Dana Lilley is retiring from the Department of Planning and Building after 29 of dedicated and valued service; and

WHEREAS, Dana began his employment with the County on July 9, 1985 as an Associate Planner; for Citizens' Housing Task Force, to assist in updating the County Housing Element, and to assist in the preparation of the Agricultural/Open Space Element of the County General Plan; and

WHEREAS, Dana was promoted to Senior Planner in August of 1991, and then to Supervising Planner in October 2000; and

WHEREAS, during his 3 years of employment by a local nonprofit affordable housing builder and his 29 years of County employment, Dana has held a high level of responsibility and has managed over \$90 million in federal and state grant funds that resulted in hundreds of affordable apartments and homes, services and shelter for homeless persons, sewer and water systems improvements in the communities of Shandon, San Miguel and Oceano, startup of the Economic Vitality Corporation and loans to many local small businesses; and

WHEREAS, Dana both completed and directed the update to the County's Housing Element of the General Plan five times, as required by State law, each time achieving State approval of the updated element; and

WHEREAS, Dana played a key role facilitating development of the Ten Year Plan to End Homeless and establishment of the Homeless Services Oversight Council; and

WHEREAS, the Workforce Housing Coalition of San Luis Obispo County selected Dana as its chairperson for the past 6 years; and

WHEREAS, Dana oversaw development of the County's ordinances which now regulate conversions of apartments into condominiums, closure or conversion of mobilehome parks, long term housing affordability, and provision of new affordable housing with market rate developments; and

WHEREAS, Dana managed the 1997 update to the County Land Use Element for the region surrounding the City of San Luis Obispo and the 2012 update to the Economic Element of the General Plan; and

WHEREAS, Dana has been the County liaison to the Economic Vitality Corporation (EVC) and assisted the EVC as it prepared its Countywide Economic Strategy and then implemented its Economic Strategy; and.

WHEREAS, Dana's 29 years of dedication to public services will be missed by all.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, that Dana Lilley is hereby commended for his 29 years of conscientious service to the people of San Luis Obispo and is wished health, happiness, lots of golf and many new adventures in the years to come.
