**RESOLUTION ESTABLISHING CHANGES TO THE TRAFFIC REGULATION CODES FOR PARKING RESTRICTIONS ON CAYUCOS DRIVE IN THE COMMUNITY OF CAYUCOS; PINE AVENUE IN THE COMMUNITY OF LOS OSOS; AND WEST CENTRE STREET IN THE COMMUNITY OF SHANDON.**



**Exhibit A**

**Amendments to the Traffic Regulation Code**  
**County of San Luis Obispo**

The following new sections are added to Chapter 15 of the San Luis Obispo County Traffic Regulation Code:

15.400.645 Pine Avenue, Los Osos

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the easterly side of Pine Avenue (County Road No. 3024) from the centerline of Ramona Avenue (County Road No. 3062) to the centerline of Skyline Avenue (County Road No. 3034).

15.402.810 West Centre Street, Shandon.

After signs are erected giving notice thereof, the following location is designated as a parking area for the exclusive use of disabled persons and disabled veterans displaying special license plates or distinguishing placards issued by the Department of Motor Vehicles: Along the northerly side of West Centre Street (County Road No. 5550) from a point two hundred thirty-five feet westerly of the centerline of First Street (County Road No. 5223) to a point one hundred ninety feet westerly of said centerline.

15.404.062 Cayucos Drive, Cayucos

After signs are erected giving notice thereof, no person shall stop a vehicle, other than a bus, at any time along the southeasterly side of Cayucos Drive (County Road No. 4287) the centerline of North Ocean Avenue (County Road No. 4256) thence northerly to a point that is one hundred seventy feet northeasterly of said centerline.
