**RESOLUTION HONORING FOURTH DISTRICT SUPERVISOR CAREN RAY FOR
HER SERVICE TO THE COUNTY OF SAN LUIS OBISPO.**

The following resolution is hereby offered and read:

WHEREAS, Caren Ray was appointed by Governor Jerry Brown on October 3, 2013 to fill the unexpired term of Supervisor Paul Teixeira and was sworn in on October 4, 2013; and

WHEREAS, Caren Ray came to the County with almost a decade of public service, after serving as Commissioner and Chair for the Arroyo Grande Planning Commission from September 27, 2005 until May 24, 2010, then as a Council Member for the City from May 25, 2010 until October 3, 2013; and

WHEREAS, Caren Ray has served on numerous committees, including the San Luis Obispo Council of Governments, Regional Transit Authority, South County Area Transit, Integrated Waste Management Authority, Air Pollution Control District, Economic Vitality Corporation, Adult Service Policy Council, and Latino Outreach Council; and

WHEREAS, during her tenure as Supervisor, Caren Ray worked with the Board of Supervisors in passing an urgency ordinance to protect the Paso Robles Ground Water Basin, delivering a balanced budget and a AAA bond rating for the County, securing open space for the use of all residents by ensuring funding for the Pismo Preserve, and serving as a member of the Workforce Housing Task Force; and

WHEREAS, as Supervisor of the Fourth District, Caren Ray reestablished and reinforced the legitimacy and relevance of the Community Advisory Councils, resolved a long-standing issue at Viva Farms, protected the residents of Mesa Dunes Mobile Home Park by defending their right to proper process, and maintained a policy of openness, fairness and commitment to constituent service; and

WHEREAS, Supervisor Ray has left an indelible mark on San Luis Obispo County for years to come by participating in the hiring of new County department heads.

NOW, THEREFORE, BE IT RESOLVED that the County of San Luis Obispo, Board of Supervisors, State of California, does hereby honor Supervisor Caren Ray for her service to the County of San Luis Obispo and wishes her all the best in her future endeavors.
