SUBJECT: Request to re-appoint Martin Settevendemie as the County Agricultural Commissioner/Sealer of Weights and Measures. All Districts.

RECOMMENDATION

It is recommended that the Board approve the re-appointment of Martin Settevendemie as the County Agricultural Commissioner/Sealer of Weights and Measures, effective March 6, 2015 through March 6, 2019.

DISCUSSION

Section 2122 of the California Food and Agricultural Code and Section 12200 of the California Business and Professions Code define the Board of Supervisors as the appointing authority for the position of County Agricultural Commissioner/Sealer of Weights and Measures. Individuals appointed to this position by the Board of Supervisors serve a renewable four year term of office.

On March 8, 2011, the Board of Supervisors appointed Martin Settevendemie to the position of County Agricultural Commissioner/Sealer of Weights and Measures effective March 6, 2011 and expiring March 6, 2015. Martin Settevendemie continues to meet all requirements for the position and is qualified to serve another four year appointment. The position will remain allocated to Bargaining Unit 09, Elected and Appointed officials and Department Heads, and receive the compensation and benefit package appropriate to positions in that unit.

OTHER AGENCY INVOLVEMENT

Martin Settevendemie possesses the required state licensing issued by the California Department of Food and Agriculture to serve as the County Agricultural Commissioner/Sealer of Weights and Measures.

FINANCIAL CONSIDERATIONS

The current costs of the position are allocated in the department's budget. The current annual compensation (salary \$134,056 plus benefits) for this position is \$209,473. No new appropriations are requested or required to implement this action.

RESULTS

The results of the appointment are that Martin Settevendemie will serve as Agricultural Commissioner/Sealer of Weights and Measures for the County of San Luis Obispo until March 6, 2019.
