**RESOLUTION ACCEPTING CERTAIN ROADS INTO THE
COUNTY MAINTAINED ROAD SYSTEM
COUNTY ROAD NOS.: 3041, 3051, 3126, 3133 and 3170**

The following resolution is hereby offered and read:

WHEREAS, it is in the public interest that the County of San Luis Obispo, State of California accept certain portions of Santa Ysabel Avenue, Seventh Street, Santa Ynez Avenue, Fairchild Way and Henrietta Avenue (hereinafter referred to as "Subject Roads") into the County Road System; and

WHEREAS, Santa Ysabel Avenue and Seventh Street have been designated as public roads by their inclusion on the Map of the Town of El Moro filed in Book A, at Page 81 of Maps, and;

WHEREAS, Santa Ysabel Avenue, Seventh Street and Henrietta Avenue have been open and available for travel for more than ten years, and have been in continuous use by the public for more than ten years, and;

WHEREAS, Santa Ynez Avenue has been offered for dedication to the public by document recorded June 30, 1970, dedication made by Bernardo Patague et al., and;

WHEREAS, Fairchild Way has been offered for dedication to the public by document recorded January 8, 1974, dedication made by Edgar H. Freeman et al., and;

WHEREAS, the County Surveyor, by letter, has duly recommended that the Board of Supervisors:

Accept the Subject Roads as described herein in the attached exhibit A into the County maintained road system.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, by the Board of Supervisors of the County of San Luis Obispo, State of California:

1. That the certain portions of Santa Ysabel Avenue, Seventh Street, Santa Ynez Avenue, Fairchild Way and Henrietta Avenue as described in the attached Exhibit A are hereby accepted into and made a part of the County Road System, to be maintained in kind, and shall and do constitute County highways in the County of San Luis Obispo.
2. That the County Clerk be and hereby is authorized and directed to record a copy of the resolution in the Office of the County Recorder of the County of San Luis Obispo.

Exhibit A

All those portions of certain roads as shown on the Map of the Town of El Moro filed January 24, 1889 in Book A of Maps at Page 81 in the Recorder's Office in the County of San Luis Obispo, State of California described as follows;

0.062 mile of Santa Ysabel Avenue between First Street and Second Street as shown on said map;

0.059 mile of Seventh Street from San Luis Street south to the westerly prolongation of the north line of Lot 37, Block 128 as shown on said map.

All that portion of Santa Ynez Avenue as described in that certain offer of dedication recorded June 30, 1970 in Volume 1571 at Page 521 of Official Records in said Recorder's Office more particularly described as follows;

0.167 mile of Santa Ynez Avenue from the southeasterly line of the Town of El Moro as shown on said map easterly to a point 731 feet westerly of the westerly line of Mountain View Avenue, County Road No. 3208 (formerly No. 3051).

0.091 mile of Henrietta Avenue from Pine Avenue easterly to the westerly right of way of Broderson Avenue (formerly East Mitchell Drive) as shown on the map of the Resubdivisions of Blocks 24 & 28 of Cuesta By the Sea filed March 15, 1928 in Book 3 of Maps at Page 48 in said County Recorder's office.

0.063 mile of Fairchild Way from Santa Ynez Avenue southerly as described in that certain offer of dedication recorded January 8, 1974 in Volume 1760 at Page 490 of Official Records in said Recorder's Office.
