**RESOLUTION AUTHORIZING AN ALTERNATIVE PROCEDURE
FOR THE DISTRIBUTION OF PROPERTY TAX LEVIES AND
ASSESSMENTS FOR THE CITY OF GROVER BEACH**

The following Resolution is now offered and read:

WHEREAS, Chapter 3 (commencing with Section 4701) of Part 8 of Division 1 of the California Revenue and Taxation Code (hereafter "the Act") authorizes the County to elect by resolution to adopt an alternative procedure for the distribution of property tax levies and assessments on the secured roll made by the County on its behalf or as the tax-levying and tax-collection agency for other political subdivisions within the County; and

WHEREAS, section 4715 of the Revenue and Taxation Code provides that entities which do not use the County Treasury as their depository may participate in the alternative tax distribution procedure by resolution of their governing board, provided such resolution is adopted by July 15th of the fiscal year in which the procedure is first to apply to such public entities; and

WHEREAS, in 1993 the Board of Supervisors adopted Resolution No. 93-262 making the alternative procedure for the distribution of property tax levies and assessments

applicable in our county to those public entities that desire to opt in to receive this method of distribution as of July 15th of the fiscal year in which the procedure is first to apply; and

WHEREAS, the City of Grover Beach desires to have the alternative property tax distribution procedure, authorized by the Act and adopted by Board of Supervisors Resolution No. 93-262, apply to it;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, that the alternative procedure for the distribution of property tax levies and assessment on the secured roll shall be applicable, pursuant to Section 4715 of the Revenue and Taxation Code, to the City of Grover Beach, for which the County Treasury is not the legal depositary, provided that the City agrees thereto by a resolution of its governing board adopted no later than July 15, 2015.
