Description of Nature, Purpose and Beneficiaries of Project

Annex additional territory to Zone A of County Service Area 7 ("CSA 7 Zone A") by aligning the boundary of CSA 7 Zone A relative to current parcel boundaries. This adjustment will correct the current unintended ambiguities which remain from previous lot reconfigurations.

Exempt Status/Findings: This project is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. It can be seen with certainty that there is no possibility that this project may have a significant effect on the environment; therefore, the activity is not subject to CEQA. [Reference: State CEQA Guidelines sec. 15061(b)(3), General Rule Exemption]

Reasons why project is exempt:

Within the territory proposed for annexation only one additional parcel could connect to the community sewer system based on current zoning. The existing community sewer system is capable of serving this additional parcel. Therefore the annexation does not substantively change the developability of parcels within CSA 7 Zone A.
